RELEASE OF SECURITY INTEREST AND RECONVEYANCE OF  
INTELLECTUAL PROPERTY

WHEREAS, Detroit Stoker Company, a Michigan corporation, with offices at 1501 E. First Street, Monroe, MI 48161 (the "Assignee"), on June 28, 2001, in a Grant of Intellectual Property Security Interest (the "Grant"), assigned certain rights, title and interest and granted a security interest in Assignee's patents and trademarks, as set forth in the attached Schedule A (the "Intellectual Property") to Fleet Capital Corporation (the "Assignor");


