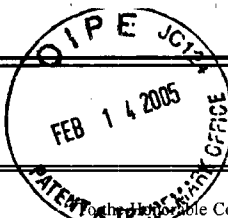

ASSIGNMENT AND AGREEMENT


