the patent application, and the Letters Patent to be obtained therefor:


Now, therefore, for and in consideration of One Dollar, and other good and valuable

necessary or desirable to perfect the Assignee's enjoyment of this grant, and will give all
necessary assistance in making application for and obtaining original, divisional, renewal,
reissued, reexamined or extended Letters of Patent of the United States and of any and all foreign
countries for the invention, in enforcing any rights or choses in action accruing as a result of such
patent applications or patents, for example, by executing preliminary statements and other

affidavits and declarations, it being understood that this agreement shall bind, and inure to the benefit of, the assigns and legal representatives of both parties.
