

for which a patent application is being filed herewith; and



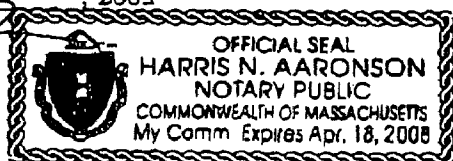
