
WHEREAS, I, Lydie Bougueleret, a French citizen, residing at 108, avenue Victor Hugo, 92170 Vanves, France, have invented certain new and useful improvements in a NUCLEIC ACID ENCODING A RETINOBLASTOMA BINDING PROTEIN (RBP-7) AND POLYMORPHIC MARKERS ASSOCIATED WITH SAID NUCLEIC ACID for which I have filed an application for Letters Patent in the United States, Application No. 09/345,882, filed on June 30, 1999;
