ASSIGNMENT

WHEREAS, I, Richard J. Adler of Tucson, county of Pima, state of Arizona, as representative of North Star Research Corporation, a corporation organized and existing under the laws of the state of New Mexico, have invented certain new and useful improvements in "Loosley Coupled Parallel Resonant Converter", for which an application was filed on February 4, 2003, and given serial number 10/357,200.
