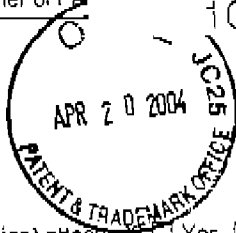

ASSIGNMENT

WHEREAS, Mr. Jeffrey CITRON, a citizen and resident of the U.S.A. having a mailing address of 2147 Route 27, Edison, NJ, 08817, USA; and Mr. Louis HOLDER, a citizen and resident of the U.S.A. having a mailing address of 6 Jean Court, Princeton Jct., NJ 08550, USA [hereinafter collectively referred to as "Assignors"], are the inventors and owners of the invention and improvements pertaining to **METHOD AND APPARATUS FOR ENHANCED INTERNET TELEPHONY**, filed **October 15, 2003** and assigned U.S. Serial No. **10/684,593**; and


