TERMINATION AND RELEASE OF PATENT SECURITY AGREEMENT

TERMINATION AND RELEASE OF PATENT SECURITY AGREEMENT, dated as of July 29, 2005, by and between LEHMAN COMMERCIAL PAPER INC., as Administrative Agent (as successor to Woodside Capital Partners II, LLC, successor to Fleet National Bank, formerly known as BankBoston, N.A.), with an office at 745 Seventh Avenue, 7th Floor, New York, New York 10019 (the "Agent") under the Patent Security Agreement (as defined herein) and HOVEROUND CORPORATION, a Florida corporation having its principal place of business at 2151 Whitfield Industrial Way, Sarasota, Florida 34234 (the "Company").

1. Release and Assignment. The Agent hereby terminates and releases its security interest in and first priority lien on all of the Company's Named Patents and the Agent hereby assigns and transfers to the Company, without recourse, all of the Agent's right, title and interest in and to each of the Named Patents effective as of the date set forth above. The Agent further agrees to execute and deliver to the Company any and all
