and all reissues and extensions thereof, together with any and all rights of priority relating to  
said invention, said applications and said Patents; and all rights to apply for and obtain  
patents in foreign countries, and the ASSIGNOR hereby authorizes and requests the  
Commissioner of Patents of the United States, and of any other country in which  
applications are filed, to issue all patents for said invention to the ASSIGNEE, its successors,  
legal representatives and assigns, in accordance with the terms of this instrument.

The ASSIGNOR has the full right to convey the entire interest herein assigned,  
and has not made, and will not make, any agreement in conflict herewith.

The ASSIGNOR further agrees to communicate to the ASSIGNEE, its  
successors, legal representatives and assigns, any facts known to the ASSIGNOR respecting  
said invention, and to testify in any legal proceeding, to sign all lawful papers, to execute all  
divisional, continuing and reissue applications, to make all declarations and to generally do  
everything possible to assist the ASSIGNEE, its successors, legal representatives and assigns,  
to obtain and to enforce patent rights for said invention in any country.
