Security Material and Fasteners Therefor


which application was executed by him on 07/20, 2005, and

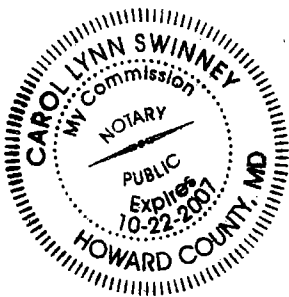


