

I hereby represent and warrant that there are no rights or interests outstanding inconsistent with the rights and interests granted herein and that I will not execute any instrument or grant or transfer any rights or interests inconsistent with the rights and interests granted herein and I, said William Bohmer, bind myself and my heirs, executors, administrators, and legal representatives, as the case may be, to execute and deliver to the said DISPLAY MATRIX CORPORATION, its successor and assigns, any further documents or instruments and do any and all further acts that may be deemed necessary by the said DISPLAY MATRIX CORPORATION, its successors and assigns, to file applications for the said improvements and said invention in any country where it may elect to file such applications, and that may be necessary to vest in the said DISPLAY MATRIX CORPORATION, its successors and assigns, the title herein conveyed or intended so as to be, and to enable such title to be recorded in the United States and foreign countries where such application or applications may be filed.




