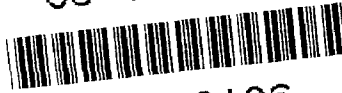


and enjoyed by us, had this assignment, sale and transfer not been made;

AND WE hereby authorize and request the agents of record in said application to insert in this assignment the filing date and serial number of said application when officially known.






