ASSIGNMENT

Whereas, ARTHUR A. KURZ, a citizen of the United States of America, residing at Wildlife Run, New Vernon, New Jersey 07976, is inventor, applicant and owner of the entire right, title and interest in all countries in, to and under certain inventions relating to MANUFACTURE OF RFID TAGS AND INTERMEDIATE PRODUCTS THEREFOR, described in an application for Letters Patent of the United States, executed by him on even date herewith;

INC., its successors, legal representatives and assigns, the entire right, title and interest in, to and under the said improvements, and the said application and all divisions, renewals and continuations thereof, and all Letters Patent of the United States which may be granted thereon and all reissues and extensions thereof, and all applications for Letters Patent which may hereafter be filed for said improvements in any country or countries foreign to the United States, including the right to claim priority under the terms of any appropriate International Convention based upon said application for Letters Patent of the United States, and all Letters Patent which may be granted for said improvements in any country or countries foreign to the United States and all extensions, renewals and reissues thereof; and they hereby authorize and request the Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for said improvements to the said A K STAMPING CO. INC., its successors, legal representatives and assigns, in accordance with the terms of this instrument.

And, ARTHUR KURZ hereby covenants that he has full right to convey the entire interest herein assigned, and that he has not executed, and will not execute, any agreement in conflict herewith.

And, ARTHUR KURZ hereby further covenants and agrees that he will communicate to A K STAMPING CO. INC. or its representatives, any facts known to him respecting the aforesaid inventions, and testify in any legal proceedings, sign all lawful papers, execute all divisions, continuations, substitutions, renewal and reissue applications, execute all necessary assignment papers to cause any and all of said Patents to be issued to said A K STAMPING CO. INC. make all rightful oaths or declarations and generally do everything necessary and desirable to aid said A K STAMPING CO. INC., its successors and assigns, to obtain and enforce proper protection for said inventions in the United States and in all foreign countries.

The Commissioner of Patents and Trademarks of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, are authorized to issue all Patents, when granted, to A K STAMPING CO. INC. as the owner of the entire right, title and interest in, to and under the same for the sole use and enjoyment of A K STAMPING CO. INC., its successors and assigns.
