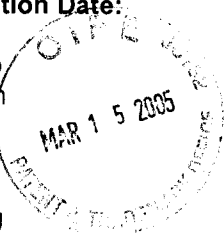

**ASSIGNMENT**

WHEREAS, Thomas H. Glimp, Troyt M. Victorson, Tim I. Sahouri, Philip C. Seeger, Curtis H. Smith, Peter B. Kleeburg, Thomas S. Huffine, and Scott A. Assignee any and all additional papers which may be requested by the Assignee to carry out the terms of this Assignment.


