ASSIGNMENT

WHEREAS, I, Allen F. Podell of Palo Alto, California, have invented certain improvements in a COUPLER WITH EDGE AND BROADSIDE COUPLED SECTIONS, for which I filed U.S. Patent Application No. 10/731,174 on December 8, 2003, and for which I executed a U.S. Patent Application on or about the date hereinafter set forth; and

WHEREAS, Werlatone, Inc., a New York corporation, having its principal place of business in Brewster, New York, is desirous of acquiring an interest therein;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which hereby are acknowledged, I, Allen F. I hereby authorize and request the Patent Office officials in the United States and any and all foreign countries to issue any and all of said Letters Patent, when granted, to Werlatone, Inc., as the assignee of my entire right, title, and interest in and to the same, for the sole use of Werlatone, Inc., and its successors and assigns.

Further, I hereby covenant to Werlatone, Inc., and its successors and assigns, at the time of execution and delivery of these presents, that I am the sole and lawful owner of

the entire right, title, and interest in and to the invention and the above-identified continuation-in-part patent application, and that the same are unencumbered, and that I have good and full right and lawful authority to sell and convey the same in the manner herein set forth.

Further, I agree that I will communicate to Werlatone, Inc., or its representatives, any facts known to me respecting the invention, and testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, reissue, substitution, and extension applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to Werlatone, Inc., make all rightful oaths, and generally do everything possible to aid Werlatone, Inc., and its successors and assigns, to obtain and enforce proper protection for the invention in the United States and in any and all foreign countries.
