

this assignment and sale not been made, together with the right to sue for and collect damages for acts of past infringement of said Patents.

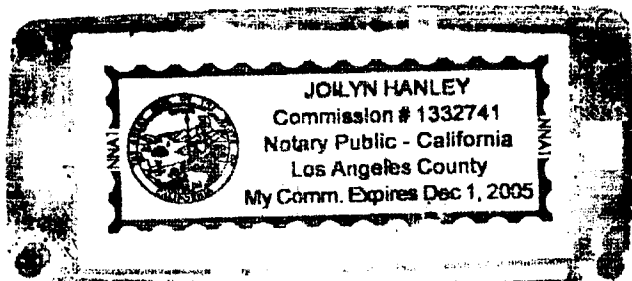


