**CONFIRMATORY ASSIGNMENT  
OF EXCLUSIVE LICENSE CONTRACT**

This Confirmatory Assignment of Exclusive License Contract is made and entered this \_\_\_\_\_ day of March 2, 2005.

WHEREAS, "Americast, a division of Valley Blox, Inc., a Virginia corporation" and Larry S. Coffman, an individual residing in Bowie, Maryland ("Coffman") entered into a contract effective November 30, 1998, which contract was modified by a Contract Modification effective May 25, 1999 (collectively, the "Exclusive License Contract");

WHEREAS, under the Exclusive License Contract, the parties entered into an agreement in which patent applications were prepared, filed, prosecuted, and subsequently issued into two patents, U.S. Patent No. 6,277,274 issued on April 21, 2001 and U.S. Patent No. 6,569,321 issued on May 27, 2003, each of which are entitled "Method and Apparatus for Treating Stormwater Runoff" in which Mr. Coffman is the sole inventor and owner of such patents and Americast, a division of Valley Blox, Inc. is the exclusive licensee under the various patent rights, including the above-mentioned patents;

WHEREAS, effective December 31, 2004, as part of a corporate restructuring, Americast, Inc. was formed as a Virginia corporation and all assets of the Americast Division of Valley Blox, Inc., including the Exclusive License Contract were transferred and assigned to Americast, Inc.


WHEREAS, the parties to the Exclusive License Contract and Americast, Inc. intend to formalize and confirm this transfer and assignment of the contract rights to Americast, Inc.

NOW, THEREFORE, for and in consideration of one dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto hereby agree as follows:


Valley Blox, Inc. transfers and assigns all rights and obligations under the Exclusive License Contract to Americast, Inc., effective *nunc pro tunc* as of December 31, 2004. The Exclusive License Contract is hereby amended to substitute Americast, Inc. as the party for "Americast, a division of Valley Blox, Inc."


Other than the substitution of Americast, Inc. as a party successor to "Americast, a division of Valley Blox, Inc.", all rights and obligations of the parties remain as set forth in the Exclusive License Contract.
