
NOW THEREFORE, TO ALL WHOM IT MAY CONCERN, be it known that for an in consideration of One Dollar (\$1.00), and other valuable and legally sufficient considerations, the receipt of which by the said Assignor from the Assignee is hereby acknowledged, the said Assignor has sold, assigned and transferred, and by these presents does sell, assign and transfer unto the said Assignee, the entire right, title and interest for the invention and application hereinabove identified, and any Letters Patent of the United States tha may issue for said invention, together with the entire right, title and interest in and to said invention and application for Letters Patent in all countries foreign to the United States, including the full right to claim for any such application all benefits and priority rights under any applicable convention; to have and to hold for the sole and exclusive use and benefit of the said Assignee, its successors and assigns, to the full end of the term or terms for which any and all of said Letters Patent for said invention may issue. And the said Assignor does hereby covenant and agree, for himself and his legal representatives, that he will assist his said Assignee in the prosecution of the application herein identified; in the making and prosecution of any other applications for Letters Patent that the said Assignee may elect to make covering the inventions herein identified, as hereinbefore set forth; in vesting in the said Assignee like exclusive title in and to all such other applications and Letters Patent; and in the prosecution of any interference which may arise involving said invention, or any application or Letters Patent herein contemplated; and that he will execute and deliver the said Assignee any and all additional papers which may be requested by the said Assignee to fully carry out the terms of this Assignment;

AND THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and intending to be legally bound hereby, said Assignor hereby assigns to said Assignee all worldwide right, title and interest in and to the said marks, together with the goodwill of the business symbolized by the said marks, and the registrations thereof and applications therefor as set forth above, and all rights to damages and profits, due or accrued, arising out of past infringements of said trademarks, and the right to sue for and recover the same.

ASSIGNOR hereby makes this assignment *nunc pro tunc* as of May 8, 2003, and agrees to execute all instruments and documents required for the making and prosecution of applications for U.S. and foreign letters patent on said invention, for litigation regarding the Patent, or for the purpose of protecting title to said invention or to the Patent.

And the Commissioner of Patents and Trademarks is hereby authorized and requested to issue Letters Patent and registrations to said Assignee in accordance with the terms of this Assignment.
