Dolores Cappelli Trust further agrees to execute any and all powers of attorney, patent applications, assignments, declarations, affidavits and any other papers in connection therewith necessary to perfect such rights, title and interest in Assignee, its successors or assigns.

Dolores Cappelli Trust hereby further agrees that it will, at the expense of the Assignee, testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and substitute applications, make all lawful oaths and generally do everything reasonably necessary to aid said Assignee, its successors, assigns and nominees, to obtain and enforce proper protection for said invention in all countries throughout the world.
