A S S I G N M E N T

WHEREAS, we, Louis P. Grasso, Jr., residing at 150 Mildred Parkway, New Rochelle, NY 10801, Louis P. Grasso, Sr., residing at 1327 Pelhamdale Avenue, Pelham Manor, NY 10803, Patrick S. Grasso, Sr., residing at 17 Lord Kitchener Road, New Rochelle, NY 10804, Elliot Kracko, residing at 143 Kensington Oval, New Rochelle, NY 10802, Cynthia A. Andela, residing at 776 County Hwy. 24, Richfield Springs, NY 13439, and Ralph J. Acampora, residing at 552 Adams Road, Coxsackie, NY 12051, have invented certain new and useful improvements in PRODUCTION OF GLASS POWDER FROM WASTE GLASS, AND PRODUCTS MADE USING THE SAME, ESPECIALLY CONCRETE, and have executed a United States patent application pertaining thereto, which application has been assigned Serial Number 11/012,726 and filing date December 16, 2004.
