SINGLE ASSIGNMENT

Whereas (name, address) Karel J. R. Vanheusden (hereinafter referred to as "Assignor" or "inventor") is an employee of the University of New Mexico (hereinafter referred to as "Assignee") and one of several inventors (the other inventors are employed by Sandia National Labs) who have made a certain invention entitled "Memory Device Using Movement of Protons" and further identified as UNM Docket No. UNM-470 for which a patent application(s) was filed on September 16, 1996 and issued Serial No. 08/714,547 in the United States Patent & Trademark Office.

Whereas under its stated policy Assignee is legally entitled to and is desirous of obtaining Assignor's entire right, title, and interest in and to said invention and to any patents that may be issued thereon in the United States or in any and all foreign countries;

The parties agree that all royalties received by Assignee resulting from commercialization of said patent application(s), patents issuing therefrom, in any and all foreign countries and in and to any and all divisions, reissues, continuations, and extensions thereof, shall be divided forty percent (40%) to the inventor, forty percent (40%) to the Science & Technology Corporation @ UNM, and twenty (20%) percent to Assignee to be disbursed in accordance with Assignee's policies.



Assignor hereby covenants that no assignment, sale agreement or encumbrance has been or will be made or entered into which would conflict with this assignment or sale.
