ASSIGNMENT

WHEREAS, Tsutomu Takeya, Kazuhiko Nakazawa, Shigeto Yamada
and Masaru Sakurai,
hereinafter called the "Assignors", have made the invention described in the United States patent application entitled THERMAL HEAD HAVING ADHESIVE INTERPOSED BETWEEN ADHESION SURFACE OF HEAT-DISSIPATION PLATE AND ADHESION SURFACE OF HEAD SUBSTRATE AND METHOD FOR PRODUCING THE SAME,

The Commissioner of Patents and Trademarks is hereby authorized and requested to issue patents to the Assignee in accordance with the terms of this Assignment.
