


ASSIGNMENT

WHEREAS, we, Ka Y. Leung and Jinwen Xiao, citizens of the United States and P. R. China and residents of Austin, Texas, have invented certain new and useful improvements in "DIGITAL POWER SUPPLY CONTROLLER WITH VOLTAGE POSITIONING" for which we are about to make application for United States Letters Patent; and

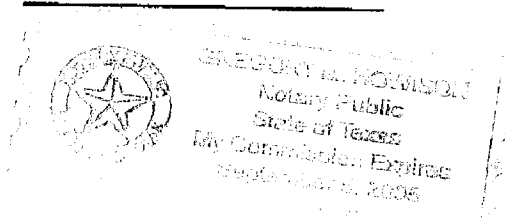

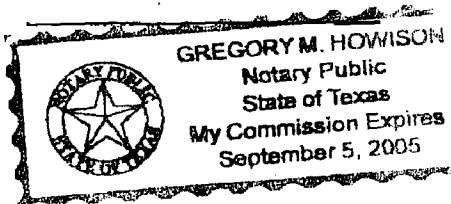
