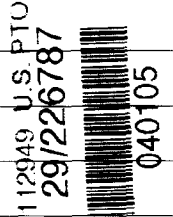

## ASSIGNMENT

WHEREAS, We, **Andrew Schonbek**, a citizen of Canada, residing at 79 Woodcliff Drive, Plattsburgh, NY 12901, and **Chad Recore**, a citizen of the United States of America, residing at 397 St. Route 22B, Peru, NY 12972 (**hereinafter INVENTORS**) have invented certain new and useful improvements in a TRIM FOR LIGHT FIXTURE for which we have executed an application for Letters Patent of the United States, of even date herewith; and

AND WE HEREBY covenant that we have full right to convey the entire interest herein assigned, and that we have not executed, and will not execute, any agreement in conflict herewith.

AND WE HEREBY further covenant and agree that we will communicate to the said **Schonbek Worldwide Lighting Inc.**, its successors, legal representatives and assigns, any facts known to me respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said **Schonbek Worldwide Lighting Inc.**, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.
