ASSIGNMENT

WHEREAS, we, Peter MacIver of Huntington Beach, California and Arron Mack of Torrance, California, have invented certain improvements in SPELLING GAMES, for which we filed U.S. Patent Application Serial No. 11/025,819 on December 28, 2004; and

We hereby authorize and request the Patent Office officials in the United States and any and all foreign countries to issue any and all of said Letters Patent, when granted, to Mattel, Inc., as the assignee of our entire right, title, and interest in and to the same, for the sole use of Mattel, Inc., and its successors and assigns.

Further, we hereby covenant and agree to and with Mattel, Inc., and its successors and assigns, at the time of execution and delivery of these presents, that we are the sole and lawful owner of the entire right, title, and interest in and to the invention and the above-


identified patent application, and that the same are unencumbered, and that we have good and full right and lawful authority to sell and convey the same in the manner herein set forth.




