# **ASSIGNMENT**

WHEREAS, Susanne Marie Crockett, a citizen of the United States of America, residing at 1214 Brandywyn Lane, Buffalo Grove, Illinois 60089; and Nancy Ann Book, a citizen of the United States of America, residing at 588 N.
