## ASSIGNMENT

WHEREAS, I, John R. The Commissioner of Patents is hereby authorized and requested to issue any and all Letters Patent solely, in accordance with this Assignment, to the ASSIGNEE, its successors, legal representatives and assigns as the ASSIGNEE of the entire rights, title and interest therein.

The ASSIGNOR further agrees to communicate to the ASSIGNEE or its representatives any facts known to the ASSIGNOR respecting the Invention, and at the expense of the ASSIGNEE, to testify in any legal proceedings, sign all lawful papers, execute all division, continuation, continuation-in-part, substitution, reissue, reexamination, and extension applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to the ASSIGNEE, make all rightful oaths and generally to do everything necessary or desirable to aid the ASSIGNEE, its successors and assigns, to obtain and enforce proper protection for the Invention in the United States and in any and all foreign countries. The ASSIGNOR and ASSIGNEE hereby authorize and request Gregory M. Stone of Whiteford, Taylor & Preston L.L.P., to insert above the filing date and application number of said application when known.
