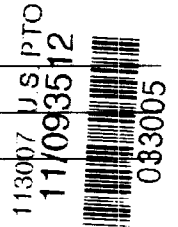

## ASSIGNMENT AND AGREEMENT


