ASSIGNMENT

WHEREAS, Douglas A. Hahn residing at 1460 North Sandburg Terrace, #1402, Chicago, IL 60610 and Bruce L. out the terms of this Assignment. Assignors authorize attorney or agent to fill in the U.S. Application Serial No. above, if required.

The Commissioner of Patents is hereby authorized and requested to issue patents to the Assignee in accordance with the terms of this Assignment.
