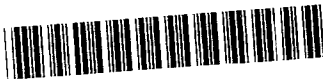

ASSIGNMENT

WHEREAS, We, Purva R. Rajkotia, resident of Plano, Collin County, Texas, citizen of the United States of America, Sanjaykumar Kodali, resident of Dallas, Collin County, Texas, citizen of India, and Chanakya Bandyopadhyay resident of Richardson, Collin County, Texas, citizen of India, have invented certain new and useful improvements in a "METHOD AND SYSTEM FOR PROVIDING MOBILE STATION CONTROL OF DATA TRANSMISSION RATES IN A WIRELESS NETWORK" disclosed in an application for United States Letters Patent (Application No. _____, filed _____), said application having been executed concurrently herewith;

We hereby further agree that we will communicate to said ASSIGNEE, or to its successors, assigns and legal representatives, any facts known to us respecting any improvements; and, at the expense of said ASSIGNEE, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and substitute applications, and make all lawful

oaths, and generally do everything possible to vest title in said ASSIGNEE and to aid said ASSIGNEE, its successors, assigns and legal representatives to obtain and enforce proper protection for said invention in all countries.
