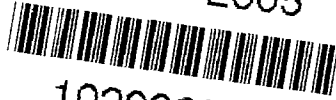



ASSIGNMENT

WHEREAS, William Robert Hurst, a citizen of the United States of America, residing at 607 Turtle Hill, San Antonio, TX 78258 ; Jeffrey Multach, a citizen of the United States of America, residing at 1910 Eagle Springs Dr., San Antonio, Texas 78248; and Steven Michael Wollmershauser, a citizen of the United States of America, residing at 750 Spacious Sky, San Antonio, TX 78258; hereinafter called the "Assignors", have made the invention described in the United States patent application entitled "Methods and Apparatus to Self-Configure a Flexible Residential Gateway," Attorney Docket No. 20103/MS1091B (SBC MS1091B), for a full description of which reference is here made to an application for Letters Patent of the United States filed on _____

Assignors authorize attorney or agent to fill in the U.S. Application Serial No. above, if required.

AND said Assignors authorize and request the Commissioner of Patents to issue Letters Patent on said application, and on any all divisions and continuations thereof, to said Assignee, its assigns and legal representatives, in accordance with the terms of this Assignment.
