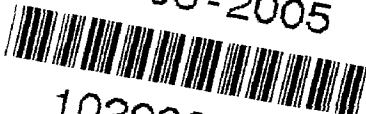



ASSIGNMENT

WHEREAS, we, *John Koke*, residing at 505 River Crest Drive, Duncan, SC 29334, *Jacob Brinkman*, residing at 37 Raymond Street, Hamilton, New Zealand, *Ron Whitehead*, 111 Ferguson Road, RD5, Hamilton, New Zealand, and *David Stevens*, have jointly made an invention relating to a vacuum packaging machine which invention is described in an application for Letters Patent of the United States entitled **VACUUM PACKAGING MACHINE**, said application was filed on August 12, 2004 and assigned Serial No. 10/504506; and

And we do hereby agree for ourselves and for heirs, executors, and administrators to execute any lawful document and to testify as to any material fact or thing which **SEALED AIR NEW ZEALAND**, its successors and assigns may deem necessary in order to secure unto itself, its successors and assigns the full right, title, and interest in and to and the full enjoyment of said invention or

any part therefor and the said Letters Patent or any of them, the same to be done without any further consideration.
