ASSIGNMENT

WHEREAS, I, **Leslie Goulden**, having an address at 301 Spagnoli Court, Los Altos, California 94022, have invented certain new and useful improvements disclosed in a patent application entitled **Combined Chemical and Immunochemical Fecal Occult Blood Test**, which was filed with the United States Patent and Trademark Office on August 12, 2005 and assigned Serial No. 11/203,050.

I hereby covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, an agreement in conflict herewith.

I hereby further covenant and agree that I will communicate to Assignee any facts known to me respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, continuations-in-part, substitute and reissue applications, make all rightful oaths and generally do everything possible to aid Assignee to obtain and enforce proper patent protection for said improvements in all countries.
