
for which a non-provisional patent application was filed with the United States Patent and Trademark Office on **June 15, 2005**, and assigned Application Serial No. 11/153,115.

I HEREBY COVENANT that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this assignment and sale; and


