ASSIGNMENT

WHEREAS, Wanda K. Beard, Paul A. Littrell and David L. Gilbert, residing at 725 N. 250 W, Angola, Indiana 46703; 5723 Fox Mill Run, Fort Wayne, Indiana 46835; and 1100 Blackthorn Cove, Fort Wayne, Indiana 46804, respectively (hereinafter referred to as Assignors), have invented certain new and useful improvements in a CABLE LOCKING DEVICE for which an application for United States Design Patent was executed on even date herewith.

FURTHER, Assignors agree to communicate to said Assignee or its representatives any facts known to Assignors respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, continuation-in-part, substitution, renewal, and reissue applications, execute all necessary assignment papers to cause any and all of said Design and Letters Patent to be issued to said Assignee, make all rightful oaths and generally do everything possible to aid said Assignee, its successors and assigns, to obtain and enforce proper protection for said invention in the United States and in any and all foreign countries.


