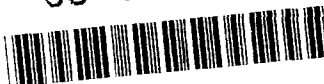

for which we have filed an application for Letters Patent of the United States on February 15, 2005, Application Serial No. 11/058,534;




