**ARTICLES OF AMENDMENT  
TO THE  
ARTICLES OF INCORPORATION  
OF  
KRONE INCORPORATED**

Pursuant to Section 7-110-106 and 7-110-108 of the Colorado Business Corporation Act (the "CBCA"), KRONE Incorporated, a Colorado corporation (the "Corporation"), hereby submits these Articles of Amendment for the purpose of amending its Articles of Incorporation:

**FIRST:** The name of the Corporation KRONE Incorporated.

**SECOND:** The **FIRST** Article of the Corporation's Articles of Incorporation is hereby amended in its entirety to read as follows:

"The name of the Corporation shall be ADC Incorporated."

**THIRD:** The effective date for the foregoing amendment shall be the later of September 30, 2004 or the date of filing with the Colorado Secretary of State.

**FOURTH:** The foregoing amendment was approved by the unanimous written consent of the board of directors and the unanimous written consent of the shareholders, in accordance with Section 7-110-103, 7-107-104 and 7-108-202 of the CBCA.
