2. The effective date of this Agreement is 15 May 2004 notwithstanding the actual dates on which it was actually signed by the Property Holders.
3. On 7 November 2003, the Property Holders entered into an Option To Purchase Assets Agreement (Option Agreement) with Goldes Holdings, LLC (Goldes). On 4 February 2004, pursuant to the terms of that Option Agreement, Goldes exercised its option to purchase the assets of the Property Holders. Paradigm Biomedical, Inc., (Paradigm) the new company formed pursuant to that option agreement *albeit* with a name change from TADJCO Biomedical Research (USA), Inc., has, by resolution of the Board, caused the transfer of 20% of the ownership of Paradigm in the form of stock to the Property Holders and has made clear that the 20% ownership of the Property Holders cannot be diluted, as provided by the Option Agreement. Further, the compensation to Goran Piljac has been effectuated by email from the attorney for Paradigm to the attorney for Goran Piljac. It also appears that payment of all the patent fees and expenses as setout in the Option Agreement have been complied with. The purpose of this Transfer, therefore, is to effectuate the Property Holders' obligations under the Option Agreement.
4. For the consideration stated in paragraph 3, above, and stated in the Option Agreement, the Property Holders hereby transfer, convey, sell, and assign all rights, title, ownership, and interest to and in all patents, pending patents, discoveries, and associated technology, including all know-how, described in Attachment A to Paradigm Biomedical, Inc. It is acknowledged and agreed by

the Property Holders that it is possible that a patent or a pending patent and its associated technology is omitted from Attachment A because of a mistake. If a patent or pending patent and its associated technology is omitted from Attachment A by inadvertence and it should have been included in Attachment A within the meaning of the Option Agreement, it is the duty of the Property Holders to transfer and assign all such patents, patent rights, and associated technology to Paradigm by this transfer. Therefore, if any patent or pending patent and its associated technology are inadvertently omitted from Attachment A, Property Holders agree to cooperate and to sign any documents to effectuate the transfer of said property to Paradigm, including documents for recording the assignments and transfers of these rights to Patent offices around the world.

In addition to the above patents, title and possession in the following are also included in this transfer to Paradigm by the Property Holders:

1. **Three (3) Strains** (species of actinomycetes) that show novel treatment effects against AIDS in vitro and human cancers.
2. **One Strain** (a species of pseudomonas) that can be formulated to produce antibiotics active against all tested (45) antibiotic resistant staphylococcus aureus and staphylococcus epidermis.
3. **Approximately 10,490 strains** derived from natural sources. These strains have been freeze-dried and are stored and ready for additional research to discover possible compounds with novel effectiveness for treatment of diseases using knowledge gathered from the research heretofore done over the last 15 years.
