WHEREAS, We, **THOMAS J. HAYES, SCOTT D. BROWN** and **H. BERNARD KIRKLAND**, have invented a certain new, original and ornamental design for the following: **CONTAINER** for which we have made application for United States Design Patent; and,

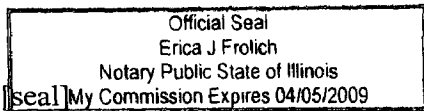
