## ASSIGNMENT

WHEREAS, We, **Daniel G. Brady**, a citizen of the United States, residing at 30121 Saddleridge Drive, San Juan Capistrano, CA 92675; **Marlene L. Paul**, a citizen of the United States, residing at 29382 Castle Road, Laguna Niguel, CA, 92677; **Elbert Y. Tzeng**, a citizen of the United States, residing at 14811 Yucca Avenue, Irvine, CA 92606; and **Robert E. Glick**, a citizen of the United States, residing at 21882 Midcrest Drive, Lake Forest, CA 92630 (hereinafter referred to as "ASSIGNORS"), have invented certain new and useful improvements in an **ACCOMMODATING INTRAOCULAR LENS WITH INTEGRAL CAPSULAR BAG RING**, as set forth in U.S. Patent Application Serial No. **10/341,701** filed **January 14, 2003**; and
