ASSIGNMENT

WHEREAS, I, Neil Skinn, residing at 2513 Pinecone Circle, Fort Collins, CO 80525-6619; I, Frank Strazzabosco, residing at 1311 Northview Drive, Erie, CO 80516-9069; I, Steve Kith, residing at 4284 S. Braun Court, Morrison, CO 80465; and Bryan S. 
