
ASSIGNMENT

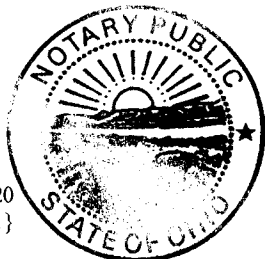
