ASSIGNMENT

WHEREAS, Yoshihiro Nishiyama, hereinafter called the "Assignor", have made the invention described in the United States patent application entitled CPP THIN-FILM MAGNETIC HEAD HAVING MULTILAYERED CONDUCTIVE LAYER BEHIND THE HEAD AND METHOD FOR PRODUCING CPP THIN-FILM MAGNETIC HEAD,

The Commissioner of Patents and Trademarks is hereby authorized and requested to issue patents to the Assignee in accordance with the terms of this Assignment.
