

## DEED OF ASSIGNMENT

THIS DEED is made on 8 July 2005

BETWEEN Ark Engineering Pty Limited (ABN 46 002 782 487) of 8 Smoothy Place, Arndell Park, New South Wales, Australia, 2148 (the "Assignor")

AND Ark Corporation Pty Limited (ABN 75 110 589 823) of 8 Smoothy Place, Arndell Park, New South Wales, Australia, 2148 (the "Assignee")

### RECITALS

- A. The Assignor is the registered owner of certain Intellectual property rights, as listed in the Schedule to this deed (the "IP Rights").
- B. The Assignor has agreed to assign to the Assignee all the Assignor's right, title and interest in the IP Rights including the right to apply for corresponding intellectual property rights throughout the world (the "Territory").

### OPERATIVE PROVISIONS

1. In consideration of one dollar paid by the Assignee to the Assignor, the receipt of which is acknowledged, the Assignor as legal and beneficial owner of the IP Rights hereby assigns to the Assignee to hold absolutely:
  - (a) the entire right, title and interest in the IP Rights;
  - (b) all corresponding rights obtained in the Territory in respect of the IP Rights and in respect of their priority dates; and
  - (c) all rights, powers, liberties and immunities arising from any statutory rights granted in relation to the IP Rights including the right to sue for damages and all other remedies in respect of any infringement of the statutory rights which may have occurred prior to the date of this deed.
2. The Assignor agrees:
  - (a) to do all acts and execute all documents necessary or desirable for further assuring the right, title and interest of the Assignee to the IP Rights;
  - (b) to deliver up to the Assignee on request all certificates of title, papers, plans, reports and items in relation to all the rights agreed to be assigned pursuant to clause 1; and
  - (c) not to do anything which may directly or indirectly prejudice or invalidate the IP Rights or their assignment to the Assignee.
3. The Assignor represents, warrants and undertakes to the Assignee that:
  - (a) the Assignor owns all right, title and interest in and to the IP Rights;
  - (b) neither the execution of this deed nor the performance of the Assignor's obligations under this deed will cause the Assignor to be in breach of any agreement to which the Assignor is a party or subject;

- (c) the Assignor has not granted any licences or other user rights to any person in relation to any right, title or interest in the IP Rights or the Design the subject of the IP Rights; and
- (d) the Assignor is not aware of any fact by which the IP Rights may be declared invalid or any claim by which the IP Rights should be amended.




