PATENT SECURITY ACKNOWLEDGEMENT

This PATENT SECURITY ACKNOWLEDGEMENT, dated as of August 31, 2005 (as amended, supplemented, amended and restated or otherwise modified from time to time, this "Acknowledgement"), is made by HARRIS MORAN SEED COMPANY, a California company (the "Grantor"), in favor of WELLS FARGO BANK, NATIONAL ASSOCIATION, as Collateral Agent (in such capacity, together with its successors and assigns in such capacity, the "Collateral Agent") on behalf of certain Agents and Banks (as hereinafter defined).

WITNESSETH:

WHEREAS, pursuant to a Second Amended and Restated Credit Agreement, dated as of August 26, 2005 (as amended, modified, supplemented or restated and in effect from time to time, the "Credit Agreement") among the Grantor the banks and other financial institutions identified therein (together with their respective successors and assigns in such capacity, the "Banks"), Société Générale, New York Branch, as Administrative Agent for the Banks (in such capacity, together with its successors and assigns in such capacity, the "Administrative Agent"); and the Collateral Agent, pursuant to which the Banks have agreed to make or maintain loans to the Borrower from time to time in an aggregate principal amount not to exceed U.S. \$42,000,000;

WHEREAS, in connection with the Credit Agreement, such Grantor has executed and delivered a Second Amended and Restated Security Agreement, dated as of August 31, 2005 (as amended, supplemented, amended and restated or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to clause (a) of Section 5 of the Security Agreement, the Collateral Agent has requested that the Grantor duly execute and deliver this Acknowledgement evidencing the Collateral Agent's continuing security interest in all of the Patent Collateral (as defined below) to secure the Secured Obligations; and

WHEREAS, the Grantor has duly authorized the execution, delivery and performance of this Acknowledgement;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantor acknowledges, for the benefit of each secured party, as follows:

SECTION 1. <u>Definitions</u>. Unless otherwise defined herein or the context otherwise requires, terms used in this Acknowledgement, including its preamble and recitals, have the meanings provided in the Security Agreement.

SECTION 2. Grant of Security Interest. The Grantor hereby acknowledges that pursuant to the Security Agreement it has granted to the Collateral Agent, for its benefit and the ratable benefit of each other secured party, a continuing security interest in all of its patents and patent applications registered with the Patent and Trademark Office of the United States of America, including each patent and patent application referred to in Schedule I attached hereto, and all

SECTION 3. Security Agreement. This Acknowledgement has been executed and delivered by the Grantor for the purpose of recording the security interest of the Collateral Agent in the Patent Collateral with the United States Patent and Trademark Office. The Security Agreement (and all rights and remedies of the Collateral Agent and each secured party thereunder) shall remain in full force and effect in accordance with its terms.

SECTION 4. Release of Liens. Upon any such disposition or termination, the Collateral Agent will, at the Grantor's sole expense, deliver to the Grantor all Patent Collateral held by the Collateral Agent hereunder, and execute and deliver to the Grantor such Documents as the Grantor shall reasonably request to evidence such termination.

SECTION 5. Further Acknowledgment. The Grantor does hereby further acknowledge and affirm that the rights and remedies of the Collateral Agent with respect to the security interest in the Patent Collateral granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein. In the event of any conflict between the terms of this Acknowledgement and the terms of the Security Agreement, the terms of the Security Agreement shall govern.

SECTION 6. Loan Document. This Acknowledgement is a Loan Document executed pursuant to the Credit Agreement and shall (unless otherwise expressly indicated herein) be construed, administered and applied in accordance with the terms and provisions thereof.

SECTION 7. Counterparts. This Acknowledgement may be executed by the parties hereto in several counterparts, each of which shall be deemed to be an original and all of which shall constitute together but one and the same agreement.
