### ASSIGNMENT

WHEREAS, I, **Nanci Schwind**, a citizen of the United States, residing at 11203 RR 2222 #1304, Austin, Texas 78730 (hereinafter referred to as "ASSIGNOR"), have invented a Photo Frame, for which a United States Design Patent Application (Serial No. 29/224,173) was filed on February 25, 2005; and

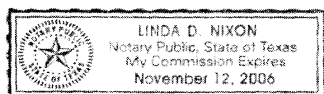
