RELEASE OF SECURITY INTEREST IN PATENTS

WHEREAS, the Patent Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on December 8, 2004 at Reel 015418, Frame 0826; and

WHEREAS, Grantor has paid all of its outstanding indebtedness to Grantee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby (i) terminates the Patent Security Agreement and the Credit Agreement, and (ii) terminates, cancels and releases any and all security interests it has against the Patents and re-assigns to Grantor any and all right, title and interest of Grantee in and to the Patents.

Grantee represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Patents; and (iii) it has not recorded or otherwise evidenced its security interest with respect to any patent or patent application owned by Grantor, other than those of the foregoing applications set forth on Schedules A and B (attached hereto), in any jurisdiction throughout the world.

Grantee shall take all further actions, and provide to Grantor, Grantor's successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
