AND ASSIGNORS HEREBY agrees to communicate to FJC or its representatives any facts known to us respecting said invention and/or Application, to execute all divisional, continuation, continuation-in-part, reexamination, reissue and foreign applications, sign all lawful documents and make all rightful oaths and declarations relating to said invention and/or Application, and to testify in any judicial or

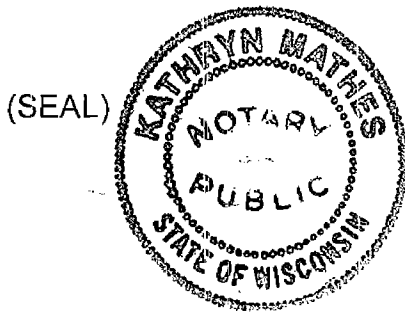


