CONFIRMATORY ASSIGNMENT

WHEREAS, **C. R. BARD, INC.** ("ASSIGNOR"), a corporation organized and existing under the laws of the State of New Jersey, having a place of business at 730 Central Avenue, Murray Hill, New Jersey 07974, was prior to September 30, 2004 the owner of all right, title and interest in and to the United States Patent Applications listed on the attached Schedule (hereinafter "**Applications**").

ASSIGNEE shall reimburse ASSIGNOR for any and all costs reasonably incurred by ASSIGNOR in performance under this paragraph.

In furtherance of this Agreement, ASSIGNOR hereby acknowledges that from September 30, 2004 forward ASSIGNEE has succeeded to all of ASSIGNOR's right, title and standing to receive all rights and benefits pertaining to the Applications, institute and prosecute all suits and proceedings, and take all actions that ASSIGNEE in its sole discretion may deem necessary or proper to collect, assert, or enforce any claim, right, or title of any kind under any of the Applications, whether arising before or after September 30, 2004, defend and compromise any action, suit or proceeding relating to such transferred and assigned rights, title, interest and benefits, and do all other such acts and things in relation thereto as ASSIGNEE in its sole discretion deems advisable.

This Agreement shall inure to the benefit of, and be binding on, the parties hereto together with their respective legal representatives, successors, and assigns.
