WHEREAS, WE , (1) Kevin O. Yin; (2) Amol Kalburge; and (3) Kenneth M. Ring residing at (1) 28 SANTA CRUZ AISLE, IRVINE, CA 92606 (2) 4371 RAFAEL STREET, IRVINE, CA 92604; and (3) 13406 Heritage Way #404, Tustin, CA 92782 have invented certain new and useful improvements disclosed in an application for United States Letters Patent titled Method for Fabricating a Bipolar Transistor in a BiCMOS Process and Related Structure, filed herewith;
